## To receive your PGW rebate check by mail, follow these steps:

- 1. Purchase the Qualifying Product(s) within the eligible promotion dates. Equipment should be installed by a licensed contractor. Review the listings at <a href="https://www.ahridirectory.org">www.ahridirectory.org</a>, or at <a href="https://www.ahridirectory.org">www.energystar.gov</a> for Tankless Water Heaters, to ensure your equipment qualifies for this program.
- Install the product(s) where there is an active meter using PGW services. Account must be eligible at the time of payout to be eligible for the
  rebate.
- 3. Mail the following to the address below:
  - a. This rebate form, completed accurately and legibly. Landlord/building owner is responsible to acquire and provide valid PGW account information for each installed equipment purchase.
  - b. A legible copy of your <u>itemized</u> invoice that shows <u>retailer/contractor name</u>, <u>address</u>, <u>phone number</u>, <u>invoice date</u>, <u>description</u>, <u>manufacturer</u>, <u>model</u>, <u>quantity</u>, <u>purchase price and proof of payment</u>.
